In the letter read above, the Commissioner of Fisheries, Hyderabad has requested the Government to accord permission to construct 40 retail fish markets with a unit cost up to Rs. 10.00 lakhs (Rupees Ten lakhs only) during the year 2016-17 within the earmarked budget of Rs. 405 lakhs, with 100% grant under the scheme of Development of Fisheries by the department and also requested to approve the operational guidelines.

- 2. Government, after careful examination of the matter, hereby approve the unit cost of Rs.10.00 lakhs (Rupees Ten lakhs only) and the operational guidelines appended herewith for construction of retail fish markets under the scheme of "Development of Fisheries" as proposed by the Commissioner of Fisheries, Hyderabad.
- 3. The Commissioner of Fisheries, and the District Collectors shall take necessary action accordingly.

OPERATIONAL GUIDELINES FOR CONSTRUCTION OF RETAIL FISH MARKETS

Introduction & Objectives:

Due to implementation of the programme of "Supply of Fish Seed with 100% grant" by the Government from 2016-17, the fish production is likely to increase and there shall be facilities for the disposal of the harvested fish, minimize post-harvest losses and ensuring remunerative price for the fishermen. At present fish markets are confined to urban areas but they are not in good condition. The Government have felt it necessary to construct as many retail fish markets as possible in all feasible places across the state in a phased manner. These markets will make fish accessible to consumers in fresh condition and provide a platform for direct marketing by the fishermen without depending on intermediaries.

Unit cost:

The Unit cost of the fish market is up to Rs. 10.00 lakhs which is given as grant to the Municipalities or Grama Panchayats.

Pattern of Assistance:

100% grant under the scheme of "Development of Fisheries".

Eligibility Criteria:

The Municipalities / Grama Panchayats /Nagar panchayat are eligible for availing the grant up to Rs. 10 lakh for construction of Retail Fish Markets under the scheme of 'Development of Fisheries" based on the estimates furnished by the executing agency as appointed by the District Collector. Municipalities/GPs/NPs are also requested to add more funding from their side to meet higher estimates if any.

Documents to be submitted:

- 1. Resolution of the Municipality or Grama Panchayat/Nagar Panchayat concerned.
- 2. Allotment of sufficient land free of cost by the Municipality/GP/NP concerned or by the Revenue Department.
- 3. Line estimates.
- 4. Undertaking by the Municipality or Grama Panchayat/ Nagar panchayat concerned that the maintenance of the fish market will be done by them at their own cost and it will be allotted for use to the local fishermen/women in consultation with DFOs with prior approval of collectors.

Components of Fish markets:

- Elevated platforms for vending of fish.
- Water facility with a bore well and over head tank.
- Facilities for cleaning the fish.
- Drainage facilities for letting out of the solid and liquid wastes as per local body laws.
- Compound wall and gate.
- Electricity connection.
- > Flooring with tiles.
- Parking area.
- Other miscellaneous requirements

Procedure for implementation:

- After receipt of proposals from the Municipality/GP/NP concerned, the DFO concerned will inspect the site and if it is feasible, the DFO will submit proposals for the approval of District Collector and entrust the work to the executing agency as decided by the District Collector
- 2. DFO will send proposal to Commissioner of Fisheries for release of funds for sanctioned works.
- 3. The District Collector shall nominate a committee with the Municipal Commissioner / District Panchayat Officer as the case may be and the District Fisheries Officer and any other official as deemed fit by the District Collector for speedy execution of works duly following the procedure and executive norms of concerned Engineering department.
