ORDER:-

In the G.O.1st read above, (7) components were approved and revised operational guidelines were issued for implementation of on going schemes under Normal State Plan " Development of Fisheries ".

- 2. In the ref.2nd read above, the Commissioner of Fisheries, Telangana State, Hyderabad has informed that the Construction of Community Halls is one of the components of "Development of Fisheries" Scheme. Under this component the eligible Fishermen Coop. Societies are sanctioned Rs. 9.00 Lakh for construction of community hall with a contribution of Rs. 1.00 Lakh from MLA/MP/ MLC or FCS. The scheme is being taken up by the department since 2014-15 and so far (244) sanctions have been accorded. The progress of the construction of community halls is not satisfactory. The delay in execution of works is due to lengthy procedure of tendering, and to speed up the work with involvement of stake holders to execute the works, requested the Government to issue guidelines with regard to the construction of community halls.
- 3. After careful examination of the proposal, in partial modification of the Guidelines issued vide G.O. read above, Government hereby accord permission to the District Collector/ Commissioner of Fisheries, T.S, Hyderabad to entrust the works of construction of community hall on nomination basis based on estimates to Fisheries Cooperative Society concerned with the following guidelines.
 - 1. The District Collector will entrust the work of construction of community hall to the Engineering Department as usual.
 - 2. The Engineering Department (Executive Agency) may entrust the work to the Fisheries Cooperative Society (FCS) who are willing to take up the work, based on estimate, without calling for tenders.
 - 3. The Estimated amount will be deposited in a new joint account to be operated by the DFO and the President, FCS concerned.

- 4. The Executive Agency will enter into the agreement for constriction of the community hall with the FCS.
- 5. The Executive Agency will prepare the plan, estimates, supervise the works and record the M.Book and recommends for payment as usual. Based on recommendation of Engineering Department, payment will be released to FCS.
- 6. In case, the FCS is not interested to take up construction of community hall work, the executive agency (Engineering Department) will take up the work as per the existing procedure.
- 4. The Commissioner of Fisheries, Telangana State, Hyderabad shall take necessary action in the matter.
- 5. This order issues with the concurrence of Finance (EBS.II) Department vide their U.O.No.7796/112/A2/2016, Dated.15.07.2016.
