The skill test shall be conducted by the above mentioned committee in the presence of the Observer and fishermen elders of the village. It will be the responsibility of the Observer to ensure presence of majority of the fishermen elders of the area of operation of the FCS and conduct of skill test in fair and transparent manner.</p>	<p><u>OBSERVER:</u> An officer nominated by the Commissioner of Fisheries, Hyderabad, not below the rank of District Fisheries Officer, will be deputed as Observer for the skill test process. The skill test shall be conducted by the above mentioned committee in the presence of the Observer and fishermen elders of the village. It will be the responsibility of the Observer to ensure presence of majority of the fishermen elders of the area of operation of the FCS and conduct of skill test in fair and transparent manner.</p>
